Working with ATC contractor, to coordinate wiring, landing points, checkout and troubleshooting as necessary of unit, and wiring, after pulling new wire.
Diagnosis: Initial Work Order	The roof top AHU is not working. We had the Spyder control for the HVAC controls replaced for this unit, but have found that the fuses keep popping when the unit is turned on and the unit will still not operate. There is no heat on the second floor. Urgent request.
