The inspections were performed on behalf of CMI Management, Inc. (US Army Reserve Offices).

The following objects were inspected at the time of the visit:

The following observations were noted during the inspection of this equipment:

Pulled the covers off of all boiler fronts, no leaks, safeties relief valves were installed properly and are ASME valves with the correct pressure and capacity ratings.

The following safety equipment was satisfactorily tested as follows: the emergency shut offs, hand lifted relief valves, local shut offs.

These boilers are marked as Glycol filled vessels. If this is the case, regular testing of the effluent should be completed in accordance with the manufacturers recommended frequency.
As a result of this inspection, there were 0 recommendations suggested with no adverse conditions noted.

A new OneCIS Operating Certificate will be issued for the object.

The next inspection is tentatively scheduled to be completed by 04/29/2020.
