Thank you for the consideration I received during my visit on April 29, 2019 at your facility listed above. The purpose of the visit was to perform the jurisdictional inspections of the objects listed below to determine compliance with jurisdictional laws and regulations. I was accompanied by James Geertgens of CMI during my visit.

The inspections were performed on behalf of CMI Management, Inc. (US Army Reserve Offices).

The following objects were inspected at the time of the visit:

The following observations were noted during the inspection of this equipment:

Pulled the covers off of all boiler fronts, no water leaks.

The following safety equipment was satisfactorily tested as follows: the emergency shut offs, hand lifted relief valves, flame out, fire eye.

These boilers are marked as Glycol filled vessels. If this is the case, regular testing of the effluent should be completed in accordance with the manufacturers recommended frequency.

As a result of this inspection, there were 4 recommendations suggested.

The OneCIS Operating Certificates are being withheld until the boilers with code recommendations have their violations cleared as listed below. Please indicate any actions taken on these recommendations by calling me at the number listed below.

The next inspection is tentatively scheduled to be completed by 04/29/2020.

### **Recommendations**

This document is advisory in nature. Reports or certificates provided in connection with any state-required boiler or pressure vessel inspection do not mean that all hazards or conditions were controlled at the time of the inspection. No liability is assumed by the information contained in this document.

The following recommendations must be completed before an operating permit can be issued.

**Condition:** Need to install a high temperature shut off with a manual reset.



**Requirement:** Need to install a high temperature shut off with a manual reset. In accordance with ASME CSD-1.

No. **2019-05-2** - Complete within 30 days  
Dunkirk-PA-080 02 located in Boiler Room

**Condition:** No thermometer is installed on these units.

**Requirement:** A thermometer needs to be installed on the discharge of the heating piping in order to monitor the safety devices. In accordance with ASME section iv.

**Condition:** Relief valve installed improperly.



**Requirement:** Install the relief valve with the spindle in the vertical position.

No. **2019-05-4** - Complete within 30 days  
Dunkirk-PA-080 02 located in Boiler Room

**Condition:** Vacuum hose on combustion air sensor is dry rotted.



**Requirement:** Replace the affected hoses.
