**Payment Schedule is as follows:** 50% is due at the acceptance of this proposal. The remaining amounts will be due at the completion of work. Any extras will be billed accordingly.

# Quantity Take-Off by Category

Project: Tidewater Inc.

The following is a categorized listing of the items that are included in the proposal for the Electrical work:

Moser Electric, LLC will supply & install a grounding system for the Pump House to include running the ground to the electrical panel, shell of building and the base of the building. Moser Electric, LLC will also supply & install a grounding system for each tank (2 tanks total) to include running the ground to each ladder, railings and the outside shell of both water tanks. This proposal includes any permit fees IF a permit is needed.

1. Prices are firm until 1/17/2020.
2. Electrical / Plumbing contractor is not responsible for protecting the premises from dirt and debris.
3. Owner/contractor will be in default if any payment called for under this agreement and all authorized change orders become past due, if any written agreement made by the owner/contractor is not promptly performed, if any conditions warranted by the owner / contractor prove to be untrue, or the failure of the owner/contractor to comply with any of the conditions of this agreement. In the event of the owner/contractor default, the Electrical / Plumbing Contractor may: 1) Suspend work and remove uninstalled Electrical / Plumbing Contractor's material or equipment from the premises. The owner/contractor agrees that Electrical / Plumbing Contractor may enter upon owner/contractor property for the purpose of repossessing such material or equipment without liability to owner/contractor for trespassing or any other reason. 2) The Electrical / Plumbing Contractor may retain all money paid hereunder, regardless of the stage of completion of the work and bring any appropriate action in court to enforce its rights. 3) The owner/contractor agrees to pay all costs and fees (including fees incurred in connection with appeals) incurred by Electrical / Plumbing Contractor in enforcing his rights under this proposal.
4. Electrical / Plumbing Contractor shall not be liable for failure to perform if prevented by strikes or other labor disputes, accidents, acts of god, governmental or municipal regulation or interference, shortages of labor or materials, delays in transportation, non-availability of the same from manufacturer or supplier, or other causes beyond the Electrical / Plumbing Contractor's control. In no event shall the Electrical / Plumbing Contractor be liable for special or consequential damages whatsoever or however caused.
5. This proposal does not include cost of trash removal, concrete, forming, painting, patching, trenching core drilling, venting and sealing of roof penetrations. All waste created by Electrical / Plumbing Contractor will be removed to a specific area on the construction site as instructed by the owner/contractor.
6. Equipment supplied by other trades shall not be required to be installed by this Electrical / Plumbing Contractor. Electrical / Plumbing Contractor shall not be responsible for owner-supplied equipment due to losses related to theft, damage, vandalism, warranty, or any associated storage expenses. This agreement does not include: 1) Warranty of equipment supplied by others. 2) Assembly of equipment supplied by others.
7. All material and equipment supplied by the Electrical / Plumbing Contractor shall be warranted by the manufacturer and will be installed in a manner consistent with standard practices at this time.
8. Electrical / Plumbing installation shall meet the National Electrical / Plumbing Code and local electrical / plumbing codes. Errors in design by the architect and/or engineer in the blueprints or specifications are not the responsibility of the Electrical / Plumbing Contractor. Any additional electrical / plumbing work required by others and not included on blueprints and specifications shall not be part of this agreement.

9. Owner/contractor and all authorized representatives of owner/contractor are not to contract or employ any employees of this Electrical / Plumbing Contractor for one year from the completion of any electrical / plumbing work performed by this Electrical / Plumbing Contractor with said owner/contractor within an area of fifty (50) miles radius from this job site.

10. Any payments not received by the invoice date should be considered past due and will accrue an additional interest charge at 1.5% per month of the unpaid balance until paid in full. No work shall be performed (including warranty) if any invoice is past due (including change orders). In addition, no release of lien shall be signed unless all payments are paid in full.

11. Reasonable time shall be given to the Electrical / Plumbing Contractor to complete each phase of the electrical / plumbing job. However, Electrical / Plumbing Contractor agrees that where a written construction schedule is provided with the signing of this agreement, the Electrical / Plumbing Contractor shall pay all overtime to complete construction in a timely manner to comply with the written construction schedule. If a written construction schedule is not provided with the signing of this proposal, the Electrical / Plumbing Contractor shall not pay for any overtime to complete project. Any overtime required shall be considered a change order and written authorization shall be required in advance.

12. Customer agrees to pay a service charge of \$25.00 each time a check is returned to the Electrical / Plumbing Contractor.

13. Warranty shall only apply to the electrical / plumbing installation of the material, fixtures, equipment, and other items supplied by the Electrical / Plumbing Contractor. Warranty shall not apply to material, fixtures, equipment, and other items supplied by others. Warranty shall not apply to extensions or additions to the original installation if made by others. Warranty shall commence from the final electrical / plumbing inspection date for a maximum period of one year. No warranty work shall be performed if any invoice is past due, including change orders.

14. Scope of Work: The scope of work is outlined in the quantity take-off reports that are a part of the proposal package.

15. This proposal is based entirely upon the walk-thru visit that took place on Wednesday, June 19, 2019. Any and all additional items that need to be added, whether required by code or otherwise, are not included in this proposal. Any items added to this contract shall be priced accordingly.
