


ACCEPTANCE: Customer signature above is an acknowledgement that the customer has inspected the work performed above and said work is acceptable and satisfactory.

It is further agreed that in the event of any dispute arising under this agreement, such matters shall be resolved through the filing of the appropriate legal action in any court of competent jurisdiction in the County of Chesterfield, Virginia.


