Problem: There seems to be a problem with the breakers tripping out for some of the exterior pole lights at the center. This is a new issue and could have possibly been caused by the construction going on, on the other side of the property.

12/09/2020 Work Note

Upon arrival contacted POC Danielle and gained access to the mechanical room where panel is for outside lighting. Breakers were off. Not tripped. Turned breakers on and turned on lights at the timer. Observed outside that lights did come on. Went back in and waited 30-45 minutes to see if breakers tripped. No breakers tripped and lighting worked fine. All power was correctly hooked up. No sign of arking or burn marks anywhere. All poles had correct power.

12/10/2020 Work Note

Today the breakers tripped. Upon inspection I found that phases were wired wrong on contactor. I fixed the wiring and now only circuit 19 is tripping. Before this light construction across the parking lot has dug up the ground to tie into the sewer system. I believe this is the cause for circuit 19 breaker tripping. Left circuit 19 off. All other lights are operable. We will have to run new wire from the second to last pole to the last pole in that run. Where the construction company has dug up the ground and tied into the sewer will need dug back up to fix broken pvc before running new wire. Will probably need a crain to pick light pole as whoever ran circuit did not leave enough in the bottom of light pole to work with. Upon repair of circuit we can then evaluate what lights needs new bulbs and ballasts.
