### DESCRIPTION OF REPAIRS:

\*\*THIS IS AN AFTER THE FACT PROPOSAL. SERVICE HAS BEEN PERFORMED AND IS NOW COMPLETE. \*\*

4/22/21- Investigated the 5 pole lights and one wall pack that are not working. There are only 5 poles on site. They are controlled by a contactor in the electric room that is controlled by a photocell on the roof. Found that the photocell and contactor are working properly and sending voltage to the site lights. They are 208V, circuit 9, panel P. Have replaced 3 of the 5 heads. 2 of the 3 are working properly. The 3rd (that is outside the fence, near the gate page station) has lost a phase in the ground. Attempted to pull the bad wire out and had no success. The feed is running under the main driveway and suspect that the conduit is crushed due to traffic. The 2 original heads also have photocells that are working but weak. Found that the general state of the whole system is in bad shape. The contactor is old and is showing signs of heat damage. The photocells are clicking open and closed but sounding very weak. The poles have extreme pitting rust damage and have the feed wires hanging out of the hand holes with split bolts that are so large they do not fit into the hand holes. The wires are showing signs of UV/weather damage. Will submit quote to fix issue.
