Repairs Needed:

Moore's is proposing to install a new lighting contactor and photocell. Tech will run a conduit from the electrical room to the exterior of the building, then into the ground to a direct burial junction box. Will then install conduit using a directional bore from the junction box to poles 1 and 4, and then from pole 4 to pole 5. Will install conduit using a trencher and mini-ex from pole 1 to pole 2, and then to pole 3. The trench to and from pole 2 will require cutting a small amount of asphalt. The existing poles will be dropped, cut up and disposed of. The new LED heads will be saved for use on the new poles. Will utilize the existing pole bases and install new anchor bolts into the bases. New 20' poles will be installed; conduit will be installed from the ground into the new poles. Will install #10 AWG wire throughout the conduit and into the new poles and terminate the connections. Proper operation of the system will be verified before completion.

Scope of Work

Replace all pole lights, control circuit, and pole feeds.

Moore's is proposing to install a new lighting contactor and photocell. Tech will run a conduit from the electrical room to the exterior of the building, then into the ground to a direct burial junction box. Will then install conduit using a directional bore from the junction box to poles 1 and 4, and then from pole 4 to pole 5. Will install conduit using a trencher and mini-ex from pole 1 to pole 2, and then to pole 3. The trench to and from pole 2 will require cutting a small amount of asphalt. The existing poles will be dropped, cut up and disposed of. The new LED heads will be saved for use on the new poles. Will utilize the existing pole bases and install new anchor bolts into the bases. New 20' poles will be installed; conduit will be installed from the ground into the new poles. Will install #10 AWG wire throughout the conduit and into the new poles and terminate the connections. Proper operation of the system will be verified before completion.

Clarifications

Tech will need to obtain 2 new pole heads. Will use the existing new pole heads on the new poles. The heads will be exact match Neptune brand. Poles will be 20' tall with a 6" to 2" taper and slip fitters. All wire will be #10 AWG CU. Lighting contactor will be Square D 4 pole with 120V coil. Photocell will be industrial grade Tork brand, 120V. Asphalt repairs will be completed with cold patch compound. Disturbed dirt will be backfilled into ditches, smoothed, and covered with seed and straw.
