Original Description: Old condenser unit OUT OF SERVICE -remove old condenser unit and dispose of unit, piping, and ROOM#2032 indoor ceiling unit ..install new ceiling grids when done .Note : leave condenser unit disconnect mounted on brick wall –see attached pictures

Repairs Needed:

Labor and Matierals to reclaim refrigerant charge if any in the system. Disconnect power. Remove electrical wire from outdoor unit to wall disconnect. Disconnect electrical wire from indoor unit to junction box. Cut out and remove copper refrigeration lines. Use lift to remove indoor unit from ceiling on second floor and down flight of stairs. Install new ceiling grid track and install ceiling tiles. Remove outdoor unit from roof down two flights of stairs.
