Shara:

What I am saying is that I provided an update for WO#17782 (Estimate #2024 Monteith, VA Hydraulic Lines) under the MD002 thread (Brandt Routine Service Diagnose), which is where you asked for a status.

My update was: *We are still waiting for the hydraulic kit to come in, hoping by next week we will be seeing them, and then we can schedule; as reiterated above.*

If it helps, let's try to keep status requests in separate threads to avoid confusion.

As for CSS# 30224 WO# 14146 & CSS# 28777 WO# 13960:

- **CSS# 30224 WO# 14146 - Estimate #1799** - Bedford, VA USARC VA099 Replace Drop Down Gate Operator: \$18,440.10

I requoted this estimate to Adam on April 27, and answered questions about lead times. According to my records, we never received approval.

- **CSS# 28777 WO# 13960 - Estimate #1727** - Richmond VA AFRC Strathmore USARC VA050 Replace Gate Operator: \$19,043.30

I requoted this to Ryan Willis on April 27 as well. Please note, this CSS #28777 is associated with WO #13632 on my end based on the CMI Document sent to me for this work. I have no records of a WO #13960. Again, I have no records of received approval.

These estimates, being as large as they are, require official, written, approvals. I provided lead times, however that does not equal approvals, and that was over a month ago. The equipment required for Gate Operator replacements averages lead times of 8-10 weeks, so if approved, we need to know as soon as possible to get equipment on order.

Please let me know if there are any approvals I am unaware of at this time.
