Original Work Request:

Flush all potable water lines to include all hot water and cold water lines. Provide chemical disinfection using a specialist biocide like chlorine dioxide, chlorine, or ozone, delivered at a high concentration for a specific period (known as "chemical shock"), ensuring the disinfectant reaches all parts of the system by running faucets and allowing the water to remain in the pipes before flushing thoroughly; this should be done by a professional following proper safety protocols and considering the specific characteristics of the water system involved. After flushing and disinfecting of all water lines is complete the water shall be tested for legionnaires bacteria using a water testing lab certified in this type of water testing.

Description of Repairs Needed:

Labor and material to a.) Sanitization of hot and cold building water system utilizing IWC's HydroTreat Process. b.) The sanitization will be approximately 8 hours where the water system cannot be used other than flushing toilets. c.) This would address the building hot and cold water plumbing system (all sinks, showers, toilets, drinking fountains, ect. that are permanently a part of the buildings plumbing) d.) Mini-split HVAC units are not a part of this sanitization. These units can create condensation as a byproduct of cooling but this water is not associated with Legionella exposure. e.) Please see the attachment (Hydro Treat Remediation Steps) for more details as well. f.) water sampling/testing at the completion of the remediation
