Original Work Request:

During (unsuccessful) service call to clear clogged sanitary sewer line which caused pooled up water in women's latrine, plumber discovered large clogs in the pipes from tree branches and the cast iron pipe had begun to deteriorate in chunks. They suspect there is a broken trap riser in the front lawn contributing to this issue. The water line is no longer able to be used (facility cannot use toilets, sinks showers) until pipe is replaced.

Work recommended on quote is as follows:

We advise excavating sanitary sewer lateral from area marked out. Dig down and locate a trap. Remove section of sanitary sewer approximately 15' long 6-8' deep. Remove buried trap and root mass. Video inspect remainder of sanitary sewer to assure there are no further issues. Install new 6" house trap. Install new 6" riser up to grade. Stone trench with clean #1 stone. Rough grade backfill and tamp.
