Grunau Company is pleased to provide you with a proposal to upgrade Kitchen Hood Suppression Systems mechanical components and agent at USAR Farrell.

Our scope of work is as follows:

Proposal is based on recommended repairs called out on February 2024 Kitchen Hood Annual Inspection reports. Proposal is also based on requested scope of work in CSS#98742 sent in for Service call W/O 16413.

Please find below specific scope descriptions for the above named facility. All work to take place during (1) mobilization to site M-F 7:00am-3:30pm. Proposal excludes any formal design, permitting or submittals.

Scope of Work- Farrell PA027

Proposal includes the following mechanical modifications to existing Ansul suppression system as well as mechanical discharge piping off this system.

System presently has (2) bottles, (1) 3 gallon bottle and (1) 1.5 bottle. Due to the amount of allowable flow points on the system, customer must replace the existing 1.5 bottle with a 3 gallon bottle. Additionally- instead of making two separate trips to replace chemical on the existing 3-gallon bottle, customer will receive a brand new 3-gallon Ansul bottle to replace the existing unit.

Scope on site @ PA027 includes:

- Modification of system piping to accommodate new 3 gallon bottle to be installed in place of existing 1.5 gallon bottle.
- Installation of new kickers. Kicker is the actuation cartridge for the new bottles.
- Replacement of stainless steel tanks and fire suppression liquid/pipe according to manufacturer specs. This includes (2) 3 gallon new Ansul agent tanks and agent to be installed within the tanks.

Note #1- Please note that there is presently an access hatch in the ceiling directly about the existing Ansul unit location. Grunau field personnel will need this access hatch to be opened during mobilization to site so that bottle piping can be modified above ceiling to accommodate the new 3 gallon bottle.

Note #2 Please note that in addition to the base mechanical and clean agent items listed directly above- this facility has the following additional modifications that should be made to the existing KH unit. These recommendations are as follows:

- Necessity for the installation of relays for electrical shutdown on the Kitchen Hood.
- Grunau recommends providing a micro-switch and install in place-however power electrical wiring to the switch to be by others.
- Grunau recommends tying in alarm system detection to existing Notifier building alarm system.
- Grunau recommends relocation of gas valve- this gas line work to be performed by licensed plumbers.
- Grunau recommends installation of an electrical power outlet behind the range- this to be by power electricians.

Note #3— Grunau's scope of work is focused on the fire protection related items at the above-named facility, specifically KH suppression upgrades/modifications. That said- there are related scope items that are outside of Grunau's internal capabilities that will be needed on this project. This includes power electrical work (tying in shunt trips to main power supply) HVAC (KH make-up air operation) and plumbing (gas valve relocation at PA027 for example) Grunau recommends General Contractor line up these other needed specialty subs and have those representatives from those subs on site for initial kick-off meeting "PCM".

Our proposal excludes the following items

1. Any Kitchen hood cleanings.
2. Any permitting with local building department(s) or other AHJs.
3. Proposal excludes Grunau providing any on-site safety officer at any point in the project.
4. Any replacement/upgrade of Kitchen Range Unit itself or addition of power outlet at PA027 Farrel.
5. Any programming of Simplex fire alarm control panels.
6. Any scope related to HVAC modifications or actual fan operations of exhausts.
7. Any new exhaust fans in the wash rack buildings.
8. Any additional 2025 or beyond Kitchen Hood inspections.
9. Proposal excludes Grunau carrying any bonds.
10. Any modifications to fire sprinkler systems at any of these facilities.
11. Usage of any galvanized pipe.
12. Any fire alarm work not outlined in the scope breakdowns for each site.
13. Any HVAC or plumbing scope.
14. Any new fire alarm drawings or modifications to existing alarm drawings.
15. Any daily safety meetings once mobilized to site for field upgrades to systems.
16. Any work on cooking components of range/ovens or replacement of existing range/ovens.
17. Grunau providing any security for the site during project construction.
18. Power wiring and disconnects
19. Any inspection of underground components or repairs to said components.
20. Any materials other than those listed in the scope description.
21. Removal of any demolished materials from site.
