Condition: Relief Valve is installed incorrectly.

Requirement: Replace/reinstall relief valve such that the spindle is in the vertical position.

No. **2019-06-3** - Complete within 30 days
Laars-WV020-4 located in Boiler Room

Condition: Relief valve is installed incorrectly.

Requirement: Replace/reinstall relief valve such that the spindle is in the vertical position.
