All office spaces have PTAC units and hallways have mini splits. Was able to locate water heater for main building and another in motor pool area. (will pm those on another ticket). Did find multiple units not operating properly. XO of site pointed out units in conference room(2 ptacs)(room number 202) not operating properly during peak temps. Also pointed to site commander office ptac (room number 206) not operating at all. Also went to motor pool to find if equipment listed for PM was there, but as said above, asset numbers were faded off. Motor pool SGT, did state all(3) mini splits and AHU in motor pool is not operating properly at all. He stated he put in an emergency call, but I stated we were only there to PM listed equipment. *Please note, even being escorted by facility operations specialist, unable to find listed equipment listed in filter replacement PM.
