WO# 17329 & 17330 Make sure regarding the boilers with the existing safety on the inlet . The inlet BOILER safety can be removed and plugged, and safety moved to the outlet side of the boiler before the isolation valve. AND must be installed vertical . Also, safety piping needs to be able to remove piping for annual inspection - and the safety discharge needs to be piped to a safe location as to prevent harm to personnel in the event of it lifting.
