*“Arrived on site checked in with Sargent Friend, located both chillers’ down for high start fault. Reset both chillers and waited for time delay at which time both cycled on and began cooling building down. Cycled chiller number one off and replaced compressor control module and cycled system back on and monitored operations in doing so another fault has become present. Both chillers are online and operational. Located controls computer and went through controls as well as further trouble shooting the newly presented fault. Upon checking the controls verified entering and exiting water temperatures at both chillers as well as the space temperatures and VAV operations for all three floors, which showed the building pulling down to set point building temps were in the high 80's so pulldown will take so time. Went through all of chiller one circuit two safeties, crankcase heaters and solenoid coil and did not find evidence for circuit two lock out and deemed it to be from the back end of the main controls between the main controller at the chiller and the BAS controls, will submit quote to further trouble shoot”.*
