

AFS Aluminum Cantilever Slide Gate 3 Year Limited Warranty

Subject to the limitations set forth below, AFS, Inc. ("AFS") warrants to the original end-user ("user") and not to any other purchaser or subsequent owner, that the aluminum cantilever slide gate (the "Product") is free from defects in material and workmanship and, under normal usage, will remain free from such defects for a period of three (3) years from the date of your original purchase.

This warranty does not apply in salty or harsh industrial environments. This warranty only applies to defects resulting from normal use. Any of the following events or conditions will void this warranty: faulty installation; damage during transportation; alteration of the product of any kind, including but not limited to affixing any other materials to the product; damage from high winds, accident, abuse, fire, or flood; damage caused by landscaping equipment or vehicles of any type, harsh or abrasive chemicals or exposure to salt or any other substance that has or includes a high mineral content, or plant growth; lack of documented monthly review and maintenance of all wear components, including but not limited to trolley assembly/rollers; or acts of God. AFS reserves the right to inspect the Product to determine validity of any claim under this warranty, including but not limited to the submittal of photos that clearly show and document the area(s) of failure. AFS may require all or part of the Product to be returned for inspection and testing.

UNDER THIS WARRANTY AFS' OBLIGATION IS LIMITED TO ONE OF THE FOLLOWING (AT AFS' OPTION), IN EACH CASE ON A PRORATED BASIS ONLY: REPAIR; OR REPLACEMENT OF DEFECTIVE MATERIAL. Reimbursements for the cost of removal and/or installation are not included and AFS will not provide such service. If the Product is replaced, the Product carries no further expressed or implied warranty. If the Product appears to have a defect in material or workmanship, user must advise the contractor from whom the material was purchased, in writing and with a copy to AFS at the mailing address provided below. In order for user to perfect your rights under this warranty, user should return a signed copy of this form to AFS within thirty (30) days of the purchase. Return of the warranty form is not a condition to warranty coverage, provided user can adequately prove that the Product installed was purchased from AFS.
