


Comments This compressed air receiver was inspected per UFC 3-430-07 and the National Board Inspection Code. It is a brand new installation. The vessel was measured ultrasonically for baseline information. It appears that the compressor that services this air receiver has never been lit off. The bottom of the air receiver has a drain fitting that is very difficult to access and/or manipulate. There is an automatic blow down device that is not connected to the air receiver but is connected to the compressor cooler.
