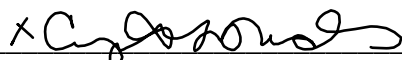

4	Check operation and setting of aquastat. Check hot water temperature with dial thermometer, and set aquastat at minimum value required for all uses.	X		
5	Drain storage and expansion tanks, and flush to remove sediment, scale, and solid at bottom of tank.	X		
6	Clean sight glasses on tanks.	X		
7	Clean strainer, check condition of traps. Report and repair leaks.	X		
8	Clean pump, controls, switches, and starters. Check operation of pump and condition of pump seal or packing, and replace as required.	X		
9	If applicable, Remove and inspect Anode, replace if necessary	X		
10	Clean up work area and remove trash.	X
